The City of Toccoa (Owner) will be requesting Statements of Qualifications from Construction Manager at Risk (CMAR) organizations (Proposers) for the construction of the following Project, and for related preconstruction and procurement CMAR services:

Owner will receive Statements of Qualifications demonstrating the Proposer's qualifications and ability to provide CMAR services and construct the Project on QuestCDN.com until January 19th, 2023 at 5:00 p.m. local time. After that time, Owner will no longer accept Statements of Qualifications. See Requests for Qualifications for details on preparing and submitting the Statement of Qualifications.

The CMAR Contract will include the following services and Work:

- Rehabilitation of an existing 0.41 MGD conventional wastewater treatment plant plus construction of new unit processes to increase hydraulic peak flow capacity, add primary treatment, and provide onsite solids handling capability. Additionally, CMAR shall provide preconstruction services including constructability review and input, preparation and submission of formal preliminary cost estimates at 30%, 60%, & 90% stages, consultation with Owner and Owner's Advisor on all aspects of planning design and proposed construction.
- 2. Modify the existing raw sewage pump station
- 3. Construct new screening & grit structure
- 4. Construct new flow control structure, flow equalization basin, and transfer pump station
- 5. Installation of approximately 13,000 LF of 8-inch DI transfer force main
- 6. Modify the existing aeration basin, secondary clarifiers, & gravity thickener
- 7. Modify the existing UV disinfection system
- 8. Modify the existing WAS pump station
- 9. Construct new digester and sludge dewatering building
- 10. Additional items as required for a complete project

Owner anticipates that the CMAR's Contract Price will be approximately \$13,000,000. The preconstruction services of the CMAR Contract has an expected start date of April 2024 and duration of preconstruction services of 120 days. The Notice to Proceed for construction is expected to occur September 2024 with a duration of 600 days. Final completion of the project is expected to be June 2026.

An Information Conference regarding the CMAR Contract and CMAR selection process will be held on January 10, 2024 at 10:00 a.m. at Toccoa City Hall – 92 North Alexander Street, Toccoa, GA 30577. Attendance at the Information Conference is encouraged but not required.

Two-Step Process

Selection of the Construction Manager will be made using a two-step process. Step One: Owner will receive Statements of Qualification and evaluate these, along with other information, to develop a list of the most highly qualified Proposers. Step Two: The most highly qualified Proposers will receive a Request for Proposals and will submit a detailed Proposal for the CMAR Contract for the Owner's consideration. The Proposal and the previously-submitted Statement of Qualifications will be used together to determine the final ranking of Proposers for award of the CMAR Contract. Details regarding the selection criteria and the selection process are included in the Request for Qualifications.

Under the two-step process the selection of the Construction Manager at Risk will be made using the following selection criteria and scoring:
